

## **VEHICLES ON OREGON TRAIL COUNCIL PROPERTIES**

- 1. All vehicles: Your final parking position will be backed into a designated parking area. Pull in, unload and then back in, this will ensure an orderly and timely departure in case of an emergency evacuation.**
- 2. During events: Vehicles that have been granted permission, may enter camp for the sole purpose of unloading program materials. Vehicles operated by those who provide essential, specialized, program support are also allowed to enter and unload. All vehicles must then return to the designated parking area for the duration of the event. The only vehicle allowed in camp, other than those owned by the camp, will be the personal vehicle of the person providing medical support.**
- 3. No 2-wheeled vehicles, bicycles, motorcycles, scooters, etc. will be allowed beyond designated parking lots.**
- 4. All camp owned service vehicles are to be operated by camp rangers only or by those authorized by the camp rangers.**
- 5. Privately owned vehicle use: Private vehicles are allowed to enter camp for the sole purpose of providing project support. They must have ranger authorization and must carry a First Aid kit, a working fire extinguisher, and obey all traffic rules and signs.**
- 6. Driving in camp: after receiving proper authorization to enter camp, you must obey all posted traffic rules and speed signs, etc.**
- 7. Self contained RV's and Trailers: No long term parking is allowed in designated parking areas, meaning 3 or more nights, (with exceptions to summer camp), without the express permission of the camp rangers.**

**8. UTV`S, ATV`S and LTV`S: Operators of these vehicles must have completed the designated manufactures specific training and must possess the certificate. They must be 18 years of age and have the express permission of the camp rangers. Operators must have successfully completed the training pursuant to the current NCAP standard FA-711. These vehicles include; golf carts (LTV), all terrain vehicles, quads, (ATV), and utility vehicles (UTV). There are NO exceptions to these requirements. Personal safety gear must be worn as directed by the vehicle manufacturer. These vehicles are to be used solely for camp operations or for the transportation of those with disabilities within camp property.**

**9. The camp rangers are granted complete and total authority to enforce these polices. They have the authority to require anyone who violates any policy to leave the specific council controlled property or to be legally charged with trespassing.**

**10. If any policy is violated and damage is caused, either by the destruction of physical property or by such action that causes additional time and resources to be spent by the rangers, the program responsible will be automatically charged a set fee determined by the council, plus the actual cost of reparation.**

**11. These policies apply equally to all properties under the control of the Oregon Trail Council with consideration given to site location and resources available.**

**12. The camp rangers are responsible for the care, maintenance and general physical upkeep of camp properties. They are charged with the responsibility to be good stewards of the land. They are not responsible for your program or specific groups who use an Oregon Trail Council property. You are therefore required to follow the policies set here and to conduct yourselves accordingly.**
